

# Memorandum of Understanding for the Implementation of the Global Internship Program (Gecho Program)



The Faculty of Mathematics and Science State University of Makassar (hereinafter referred to as "FMIPA") and the Center for Global Internship Program, Hiroshima University (hereinafter referred to as ("Gecbo") agree to the following terms regarding the implementation of the global internship program.

#### (Objective)

Section 1 The objective of the Gecbo Program is to promote the learning and training of graduate students through global internship mainly in Asian and African countries and to prepare them to become future leaders or practical researchers in international society.

#### (Place)

Section 2 The internship is carried out in the following place:

Workplace: Faculty of Mathematics and Science (FMIPA) State University of Makassar

# (Period)

Section 3 The period of internship is from January 7<sup>th</sup> to February 22<sup>nd</sup>, 2019
Name of intern: Ms. Uswatun Hasanah

#### (Contents)

Section4 The contents of the internship are to be decided after consultation with both parties considering the intern's specialization and capacity.

# (Supervision)

Section 5 FMIPA and Gecbo take responsibility for supervising the intern by maintaining close communication between both parties.

#### (Supervisors)

Section 6 FMIPA and Gecbo assign the supervision of the internship to their staff/employees indicated in the attached table below.

# (Payment of expenses)

Section 7 Internship expenses shall be borne such as travel, accommodation, food and other incidental relevant to the internship shall be for the account of Gecbo or the intern. FMIPA does not provide salaries or allowances to the intern.

## (Obligation)

Section 8 Gecbo requires the intern to make a pledge on the following when the internship is carried out in FMIPA's workplace.

- (1) To strictly follow FMIPA's rules and regulations.
- (2) Not to reveal any information obtained during the internship to a third party without FMIPA's permission.

## (Using Facilities and Equipments)

Section 9 FMIPA allows the intern to use FMIPA's facilities and equipment without charge within the limits that FMIPA recognizes their necessity for the internship.

# (Contingency)

- Section 10 (1) In case of a contingency, the intern follows the risk management policy of FMIPA in principle.
  - (2) The compensation for any damages or injuries caused by a contingency or accident is covered by the Personal Accident Insurance for Students Pursuing Education and Research and overseas travel accident insurance, both of which the intern shall acquire in advance. FMIPA is not required to take responsibility beyond the damages covered by insurance indicated above in principle.

## (Publication of results)

Section 11 The publication of research results gained by the intern over the period of her internship is to take place only after consultation with FMIPA and G.ecbo.

(Cancellation or change of internship)

Section 12 In the event that the contents, period or place of internship need to be changed or cancelled after prior agreement has been made, FMIPA, G.ecbo and the intern shall discuss to get a mutual consent in writing.

(Documents for visa application)

Section 13 If the country where the internship takes place requires visa for intern, FMIPA and G.ecbo will prepare the supporting documents for the intern to obtain an appropriate visa.

(Consultation)

Section 14 For additional provisions or changes to this agreement, FMIPA and Gecbo decide after consultation whenever necessary.

In witness to the conclusion of this agreement, two copies of this Memorandum of Understanding shall be made. FMIPA and Gecbo shall sign and seal the two copies, after which FMIPA and Gecbo retain one copy of each.
